Meeting called to order at 7:00 p.m. by Jason Meyer with Pledge of Allegiance.

**Meeting Minutes:**

Brian motions to approve the September 10th, 2019 Meeting Minutes. Rachna seconds. Approved.

**2020 Budget:**

Mike reviews one last time for the board. Rachna motions to approve the 2020 Budget. Brian seconds. Jason approves also. 2020 Budget Adopted.

**2020 Tax Rate Resolution:**

Mike reviews one last time for the board. Brian motions to approve the tax rate resolution. Rachna seconds. Jason approves also. 2020 Tax Rate Resolution is approved.

**2020 Salary Resolution:**

Doug reviews it with the board. Brenda's updated salary that was approved by the board in September will hold and remain the same for 2020. No increase for elected officials. Standard 3% raise will be given to Jeri. Rachna motions to approve. Brian seconds. Jason approves also. 2020 Salary Resolution is adopted. Doug will remain at \$50,000. Board will remain at \$5,000 each. Brenda will remain at \$27,500. Jeri will increase to \$46,865.

**Landscaping Update:**

Doug reviews and updates on all of the landscaping makeovers, updates, repairs being done to the township buildings. Estimated cost is \$3400. Expected completion is by year end.

**Park Update:**


Doug stated that Doug Waggoner with Republic agreed to an easement. Waggoner stated he would put in but that the City of Fishers wants it paved and 12' wide and for it to be used in conjunction with Flat Fork. Megan Schaffer with the City worked with Republic on the easement. Doug (FCT) asked that Republic pay for the easement, after much deliberation, Doug Waggoner agreed. In an on-site review of the easement, Doug (FCT) found that the easement was not paved, permanent markers removed, ton of fill was brought in, trees were cut back to the line and the ravine was filled with boulders. However, it was acceptable to Megan Schaffer and Captain Orusa. Doug (FCT) believes it will paved in the future. Cardno is working on a proposal for the trails. Bridge work should start this year as well. Doug had the parking trimmed up and mowed. He asked that Cardno not do another yard mow to allow grass for rabbits. Doug (FCT) also gave updates on the prosecution of the illegal dumping on the parks ground and the citation for deer hunting on the property.


**Assistance Update:**
